## 150/24 COOPTION FOR THE VACANCY OF COUNCILLOR IN BILLINGHAM SOUTH WARD

One application was received and circulated to members before the meeting. The applicant gave a short presentation and answered questions from members. A vote was then taken.

Janet Atkin was coopted onto the Town Council for the vacancy of Councillor in the Billingham South Ward. The Acceptance of Office form was duly signed.

### 151/24 STOCKON BOROUGH COUNCIL (SBC) WARD COUNCILLOR UPDATES

The following updates were given:

Billingham North

- New signage has been installed at Haydon Green Play area to discourage dog fouling;
- Ward Walkabouts taking place with PCSO's on Saturday 26<sup>th</sup> January at 3pm, meeting at High Grange Community Centre. Residents are welcome to attend;
- The cameras on Casson Way at the shops are proving to be effective, complaints have reduced;
- Still looking at installing security cameras at High Grange play area however annual monitoring costs are expensive. Possibly move the camera from the shops to the play area;
- Accidents on the Sealsand road/Marsh House avenue road, looking at a way to reduce the accidents using funds from the Ward Transport budget.

**Billingham East** 

- Ongoing development at St Josephs. The work on the Sports Hub commences Spring 2025;
- Scaffolding up at Low Grange Club;
- Looking at issues in relation to changing grassed areas into hardstanding;
- Next Ward Surgery is Friday 14<sup>th</sup> February;

- Bread & Butter Project ongoing every Wednesday at the New Life Centre;
- Looks at issues with the paths on Low Grange Avenue;
- Casework pot holes, parking etc.

## Billingham Central

- Continuing the meetings with Thirteen Group, including discussions over Dawson House. Not happy with explanations from Thirteen group regarding housing situation in Billingham;
- A second traffic survey has been conducted on Pendle Crescent with the strip put in a different location from resident's requests. The results from the second survey did not meet any criteria for bollards, speed bumps etc;
- Still looking at options for the hard standing areas on Melrose Avenue;
- Casework including dropped kerbs, parking bays etc;
- Looking at the issue of people bringing cars into John Whitehead Park;
- A full leaflet drop was not carried out at the end of 2024 as planned, targeted drops are taking place;
- The crossing on Station Road will be closed from 11.20pm on Saturday 8<sup>th</sup> February to 9.15am on Sunday 9<sup>th</sup> February;
- Looking at the issue of the strip that you drive over that needs flattening near the Swan Pub;
- The gas board are currently doing works on Cheviot Crescent and Cotswold Crescent that is causing congestion in the area;
- Determined to make the new town centre a dementia friendly area.

## Billingham South

- Newletter delivered over the Christmas period;
- Door knocking sessions carried out, giving out information on Pension Credit;
- Design agreed for the new play area on Mill Lane field;
- Looking at traffic calming measures on New Road;
- Working out the route/timings for the new bus service that will run from Port Clarence to Billingham, then Norton and North Tees Hospital. It is proposed that one bus will run on Monday's, Wednesday's, Friday's and Saturday. Should be available in approximately three months time;
- Taking a motion to SBC to bring buses back under public control;
- Lots of well attended events taking place at Billingham Synthonia Cricket Club however, issues with antisocial

behaviour and parking outside the venue. Future events will be going through SBC's ISAG process;

- Dealing with issues at the allotments in Port Clarence, meeting held with BELP and council officers;
- New playing field at High Clarence school;
- Northumbrian Water Authority installing property prevention measures to those affected by flooding in Port Clarence;
- Fly tipping continues to be an issue in Port Clarence;
- Dealing with issues with private landlords regarding properties at Limetrees Close, Community Protection Warnings and Notices have been issued and there is some improvement from 6 months ago.

#### **Billingham West**

- Still waiting for noticeboard to be installed;
- Issues with parking on grass verges at Northfield;
- Still working on issues with speeding in the ward;
- Carrying out casework on planning issues, trees, potholes;
- Assisting local groups to get funding.
